WHEREAS Gomantak Gausevak Mahasangh, Sikeri, Mayem, Bicholim-Goa an AWO for establishment for any stray cow shelter at Sikeri Mayem and is fully equipped and functional from 2015 for taking care of stray cows.

WHEREAS the FIRST PARTY to continue to manage and run the stray cows and continue to lift the roadside cows within the jurisdiction of Village Panchayat Khajne Amere Porascadem as and when the SECOND PARTY request the FIRST PARTY.

NOW THIS MEMORANDUM OF UNDERSTANDING WITNESSETH AS UNDER:

1. The FIRST PARTY shall impound the stray cows from the road and public places within the jurisdiction of Village Panchayat Khajne Amere Porascadem and transport them to Salem Gaushala for providing shelter to the stray cows.
2. The SECOND PARTY shall bear all the cost of impounding, rescue and maintenance charges for the stray cows from the jurisdiction of Village Panchayat Khajne Amere Porascadem till all the stray cattle survive in the Gaushala.
3. The SECOND PARTY shall pay all the assistance/Financial assistance/Grants to the FIRST PARTY as obtain/received under "The Goa Stray Cattle Management Scheme, 2013 (Amended)" from Animal Husbandry & Veterinary Services Department, Government of Goa without any delay to disburse the amount to the SECOND PARTY after furnishing the Utilization Certificates and Auditors Report to the Animal Husbandry Department as required under the scheme.
